FUNCTIONS

Heading

- Coordinate the cyber security team of the ESDC
- Lead on the specific cyber security training programmes (FC 2)
- Lead on coordination and liaison for EU and member states' cyber security ETEE initiatives

Planning

- Plan the annual training programme in the field of cyber security
- Plan and implement e-learning in cyber security courses
- Contribute to the functioning of the eLCIP Board configuration
- Plan and contribute to networking events of the ESDC in general or within the cyber security context

Analysis and Evaluation

- Contribute to the Lessons Identified Process of the ESDC drawing on the expertise of the relevant services in the EU institutions and agencies
- Evaluate the relevant training activities and ensure that lessons identified are reflected in next courses
- Analyse different pedagogic approaches for new courses and advice which one is the most appropriate and cost-effective
- Analyse the various EU and national level training activities in the field of cyber security in close cooperation with the discipline leaders from EUMTG and EUCTG
- Support to the development of Standardised Curricula in the field of cyber security
- Provide ESDC input to the relevant reports (e.g. GAREA)
- Map and analyse the EU Cyber ETEE landscape in close cooperation with SecPol and EDA

Project Management

- Facilitate the conduct of ESDC training, education and exercise activities in the field of cyber security
- Support continuous development and review of training analysis, needs and requirements
- Develop new training, education and exercise activities in the field of cyber security

- Cooperate with other training providers and research institutes in the field of cyber security, such as ENISA, EUROPOL, CEPOL
- Contribute to the development of a dedicated platform for cyber security, including interested partner countries
- Develop training material for ESDC courses in the field of cyber security

Coordination

- Establish close contacts to the Points of Contact of national and international training and research institutes
- Keep contact and closely co-operate with relevant services in the EU-institutions, the EEAS and EU agencies
- Coordinate the work related to the conduct of the cyber security activities
