

Business and Innovation Forum Bulgaria - Switzerland June 15th, 2016, Sofia

The Business and Innovation Forum organized by the Bulgarian — Swiss Chamber of Commerce (BSCC) in cooperation with the Embassy of Switzerland in Sofia and the Sofia Tech Park takes place on the margin of the official visit to Bulgaria of the State Secretary for Economy of the Swiss Confederation and Head of the State Secretariat for Economic Affairs (SECO), Mrs Marie-Gabrielle Ineichen-Fleisch, accompanied by a Swiss business delegation.
