#### **Job Content**

The SNE will work in the Strategic Policy Planning Division (SG1-STRATPOL) a central service under the direct authority of the Secretary General. STRATPOL provides contextualised and comparative analysis on emerging challenges, policy making and overall steering on aid programming framework as well as direct political advice to the SG and the EEAS top management as well as to the High Representative.

## Overall purpose:

- Provide analytical insights and recommendations for EU policy planning and making on the increased role Religion and religious actors play in societal and political dynamics in the main contexts of EU external action, as part of STRATPOL's direct political advice to the HR and EEAS top management
- Provide advice on preparation of the orientations for the next programming cycle of the Multiannual Financial Framework with respect to funding of relevant activities that can contribute to address effectively and constructively Religion dimension in EU funded activities.
- Contribute to EEAS Public Diplomacy efforts notably vis-à-vis the think tank community and the broader public in the area of Religion.

# **Functions and Duties**

 Advise the HR and the EEAS on Religion and Freedom of Belief, prosecution of minorities for religious, apostasy or atheism notably in developing countries (ODA eligible), hereunder issues related to the nexus of religion, diplomacy and development.

- Provide methodological advice and guidance on how better integrate the Religion dimension in the various activities related to conflict prevention, peace and mediation and post-conflict stabilization as well as recovery and development programmes.
- Provide practical and operational guidance to EEAS on promotion and steering of Religion and FoRB projects in the implementation of the new development instrument NCIDI (Instrument for Neighborhood, Development Cooperation and International Cooperation) in ODA-eligible countries during the next phase of the MFF. Develop with relevant Commission services guidelines on funding of Religion-related activities (incl. FoRB) in countries covered by the NDICI.
- Provide Advice to the EU delegations on Religion related activities and projects
- Specific roles: member role in the EU Exchange Platform on Religion in Society; Fulfil
  member role of the Global Steering Committee for the Implementation of the UN Plan of
  Action for Religious Leaders in the field of Conflict and Atrocity Prevention, notably in
  developing countries (ODA eligible). Represent the EEAS in the Transatlantic Policy Network
  on Religion and Diplomacy (TPNRD).
