I am aware of the need to have an adequate travel medical insurance for my first stay and any subsequent visits to the territory of the Republic of Bulgaria

如果申请多次入境 (见第 24 项) 签证: 本人了解每次入境保加利亚都需购买足额的旅游医疗保险。

I am aware of and consent to the following: the collection of the data required by this application form and the taking of my photograph and, if applicable, the taking of fingerprints, are mandatory for the examination of the visa application; and any personal data concerning me which appear on the visa application form, as well as my fingerprints and my photograph will be supplied to the relevant authorities of the Republic of Bulgaria and processed by those authorities, for the purposes of a decision on my visa application.

Such data as well as data concerning the decision taken on my application or a decision whether to annul, revoke or extend a visa issued will be entered into, and stored in the Visa Information System (VIS) (1) for a maximum period of five years, during which it will be accessible to the visa authorities and the authorities competent for carrying out checks on visas at external borders and within the Republic of Bulgaria, immigration and asylum authorities in the Republic of Bulgaria for the purposes of verifying whether the conditions for the legal entry into, stay and residence on the territory of the Republic of Bulgaria are fulfilled, of identifying persons who do not or who no longer fulfil these conditions, of examining an asylum application and of determining responsibility for such examination. Under certain conditions the data will be also available to designated authorities of the Republic of Bulgaria and to Europol for the purpose of the prevention, detection and investigation of terrorist offences and of other serious criminal offences. The competent authority of the Republic of Bulgaria responsible for processing the data is MFA.

I am aware that I have the right to obtain in any of the Republic of Bulgaria notification of the data relating to me recorded in the VIS and of the Member State which transmitted the data, and to request that data relating to me which are inaccurate be corrected and that data relating to me processed unlawfully be deleted. At my express request, the authority examining my application will inform me of the manner in which I may exercise my right to check the personal data concerning me and have them corrected or deleted, including the related remedies according to the national law of the Republic of Bulgaria. The national supervisory authority, which will help me and indicate how to exercise these rights, is the Commission for Personal Data Protection.

I declare that to the best of my knowledge all particulars supplied by me are correct and complete. I am aware that any false statements will lead to my application being rejected or to the annulment of a visa already granted and may also render me liable to prosecution under the law of the Republic of Bulgaria.

I undertake to leave the territory of the Republic of Bulgaria before the expiry of the visa, if granted. I have been informed that possession of a visa is only one of the prerequisites for entry into the Republic of Bulgaria. The mere fact that a visa has been granted to me does not mean that I will be entitled to compensation if I fail to comply with the relevant provisions of Article 5(1) of Regulation (EC) No 562/2006 (Schengen Borders Code) and I am therefore refused entry. The prerequisites for entry will be checked again on entry into the territory of the Republic of Bulgaria.

本人了解并同意下述内容：此申请表格所要求的信息，本人的照片以及指纹（如适用）是受理签证申请的必要条件。申请表中任何关于本人的信息，本人的指纹和照片都将提供给保加利亚的相关机构以便其对本人的申请做出决定。

同决定本人申请结果相关的信息或者是否拒绝、取消或者延期已获批准签证的决定都将被录入并保存在签证信息系统（VIS）(1)中，保存期限最长为五年，在此期间签证受理机构，负责在边境及保加利亚境内检查签证的主管部门，以及保加利亚的移民和难民机构有权根据该系统中的信息核实是否具备合法入境以及在保加利亚境内停留和居住的条件，对不符合或不再符合这些条件的人员予以辨别，审查难民申请并对此审查确定职责范围。在特定条件下，保加利亚的指定机构和欧洲警察组织还可以利用该系统中的信息，侦破和调查恐怖袭击和其他严重犯罪案件并预防此类案件的发生。在保加利亚负责处理签证信息的主管机关是外交部。

本人了解：本人在保加利亚有权获知任何一个成员国保存在签证信息系统中关于本人的信息以及提供该信息的成员国名称，有权要求更正关于本人的不准确信息，有权要求删除在非法使用中的关于本人的信息。一经本人要求，审核本人申请的机构将会告知本人将以何种方式行使核实，更正或者删除个人信息权利，根据保加利亚的当地法律采取相应的补救措施。该国的监督机构也会举办听证会主张保护个人信息。

本人声明：本人所提供的所有信息都是完整而准确无误的。任何有误的信息都将导致本人的申请被拒绝或者获批的签证被取消，还可能根据受理保加利亚的法律使本人受到起诉。

如果申请获得批准，本人保证在签证有效期内离开保加利亚。本人知道获得签证仅仅是入境保加利亚的先决条件之一，如果本人违反了欧共体第 562/2006 号（申根边境代码）第五条第一款的规定，即使获得签证也会被拒绝入境而无权提出赔偿。在入境保加利亚边境时，入境条件将再次被核查。
