

## FIRST ADDENDUM TO AGREEMENT

This Addendum Agreement is made by and between

**The Ministry of Foreign Affairs of the Republic of Bulgaria** having its current address at 2, Alexander Zhendov Str., Sofia 1040, Bulgaria, hereinafter referred to as "The Ministry", represented by Eleonora Dimitrova Dimitrova, Ambassador Extraordinary and Plenipotentiary of the Republic of Bulgaria to India.

**AND**

**VFS Global Services Private Limited**, a Company incorporated under the provisions of (Indian) Companies Act, 1956 having its Registered Office at 9th Floor, Tower A, Urmi Estate, 95, Ganpatrao Kadam Marg, Lower Parel (W), Mumbai 400 013, India (hereinafter, for the sake of convenience, referred to the '**VFS Global**', which expression shall unless it be repugnant to the context or meaning thereof shall mean and includes its successors and assigns).

**The Ministry and VFS Global together referred to as the 'Parties' and each individually as a 'Party'.**

### **WHEREAS**

1. VFS Global is engaged in the business of providing technical and administrative support services to Diplomatic Missions and Foreign Consular Offices.
2. The Ministry has engaged the services of VFS Global to provide Bulgaria visa services in accordance with the terms and conditions of the Agreement dated 14<sup>th</sup> October 2019 (hereinafter referred to as "Original Agreement") which is valid for two years from 14<sup>th</sup> October, 2019.
3. The Original having come to an end the Parties wish to extend the term of the Original Agreement vide this Addendum.

Now this Addendum witnesseth and it is hereby agreed by and between the Parties as follows:

### **The Parties hereby agree that:**

- a) By this Addendum the Parties agree and hereby do further extend the term of the Original Agreement for a period of twelve months and the extension of the Original Agreement shall commence from 14<sup>th</sup> October 2021 and shall be valid up to 13<sup>th</sup> October 2022, both days inclusive.
- b) This Addendum Agreement is an integral part of the Original Agreement executed between them pertaining to the subject matter of the Original Agreement.
- c) This Addendum Agreement shall be executed in 2 (two) number of counterparts, each of which shall be deemed to an original, and such counterparts together shall constitute one instrument. Each party shall retain one counterpart.
- d) Visa Fee for each application is Euro 80.
