### TREATIES AND AGREEMENTS BETWEEN NATO MEMBERS AND THE SOVIET UNION AND EASTERN EUROPEAN STATES

At the Council's meeting on 15th March, 1967, a number of Permanent Representatives expressed an interest in the compilation of a list of bilateral treaties and agreements which are either in force, under negotiation, or contemplated between NATO member governments on the one hand, and the Soviet Union and Eastern European states on the other hand.

- 2. In accordance with the Council's intent, the International Staff has compiled the attached information about treaties and agreements based on data furnished by Delegations. In the economic field, this document completes information collected since 1962 by the Committee of Economic Advisers on trade agreements(1). Only treaties and agreements concluded since 1st January, 1946 and still in force have been included, as agreed by POLADS(2).
- 3. The document has been printed in looseleaf binder form so that periodic changes may be registered and additional information added as needed.

- 2. The purpose of ANNEX A is to present graphically a comparative picture of the main areas where East-West agreements exist or are envisaged.
- ANNEX B lists all treaties and agreements about which the International Staff has been informed political and general in four broad categories: economic and commercial relations; relations; scientific and cultural relations; and consular and The list is limited to administrative relations. those agreements concluded after 1st January, 1946 and still in force, and those under negotiation or Cross-references have been used where contemplated. a single agreement seems to cover more than one as for example, economic as well as category; scientific, technical or even cultural matters. order to ensure uniform presentation it has been necessary to put certain treaties in categories other than those which Delegations had indicated in their submissions to the International Secretariat. Generally each treaty listing contains a treaty title, date of signature, date of entry into force, period of validity, and an indication of the reference document in which the treaty was published.
