Page 9, paragraph 22

Delete the existing paragraph and insert the following:

Paragraph 30

5th sentence, replace by the following:

"It hoped that the General Assembly would be willing to renew the mandate of the Committee of 33 on the problems of peacekeeping and that the latter would find itself able to play a more active part than it had done in recent years."

7th sentence, replace "United Nations agencies" by "United Nations bodies".

Paragraph 31

DECLASSIFIED/DECLASSIFIEE

Replace by the following:

"Drawing attention to the Agenda item on the election of five non-permanent members of the Security Council, he pointed out that two of these must be selected from among the Western countries and that, of the three candidates for these seats, Italy and Belgium seemed to have considerable backing in the Speaking on behalf of his Government, he thanked Western group. the Allied countries which had already promised their support and hoped that a solution could be found which would enable the group of Western countries to put forward only two candidates for the two seats to which it was entitled."

Paragraph 32

lst sentence, replace by the following:

"In his view, the problems of disarmament could be the most important issues to be dealt with at this session."

2nd sentence, insert the word "definite" after "He had no ... "

Paragraph 35

3rd sentence, replace by the following:

"As regards the proposal by the Soviet Union, Bulgaria and Syria on the breadth of the territorial sea, he recalled that following a Soviet move, a United States-Soviet draft had been tabled in 1968. During consultations in the Council, Italy had made various objections to this draft, particularly in connection with the provisions for straits. This matter was of vital importance for Italy's defence, security and economy."

Paragraph 37

lst sentence, replace by the following:

"In conclusion, he expressed concern at the future outlook for the International Labour Organization following the United States decision to cut down its contribution."
