Only applications received in the above-mentioned format by 10 January 2022 at noon (CET-Brussels' time) will be considered for this call for applications.

Division RM.BHR.3 of the EEAS will examine the applications as far as it is concerned, and the ESDC will organise selection interviews in January 2023.
