

SECONDED NATIONAL EXPERT- JOB PROFILE

Operational Officer

(Coast Guard Sector/ Coast Guard and Law Enforcement Unit/ Operational Response Division)

Tasks and responsibilities:

Reporting to the Head of Coast Guard Sector and/ or to the Senior Coordinating Officers of the Coast Guard Sector, the main duties related to these positions are:

- To contribute to the sector's operational activities at the EU external maritime borders, in particular in terms of the development and smooth implementation of the operational tasks assigned to the Unit;
- To manage and coordinate operational activities at the EU external maritime borders, including identification of operational needs, planning, implementation and evaluation of operational activities, reporting on operational results according to instructions provided by the Sector's management. These activities encompass, inter alia, the preparation of operational plans/ specific activity plans/ Specific Modalities, reports, written communications, briefing notes and responding to enquiries related to the activities and/or coordination of implementation measures in the operational areas;
- To contribute to the development of the EU cooperation on coast guard functions specially by bringing his/her expertise on SAR and knowledge of EFCA and EMSA activities;
- To contribute with his/her professional competencies to the different tasks of the sector where he /she is involved in, facilitating the application of sound management of the work and achievement of objectives;
- To coordinate and organize meetings, workshops related to Search and Rescue and other coast guard functions and to establish a European network for cooperation in the field of Coast Guard Functions;
- To follow the latest developments, technologies, methods and practices in the field of Unit/Sector's activities and promote their implementation within the sector's activities;
- To provide the Sector's management and other team members with expertise on all aspects of coast guard functions and Integrated Border Management based on his/her professional competencies, promoting best practices and knowledge-sharing within the team and the sector.

<u>Selection criteria:</u> Professional gualifications, competencies and experience required:

Essential:

- At least 5 years of experience in management and/or implementation of operational activities at sea in the area of border control/law enforcement and/ or other Coast Guard functions
- > Experience of working in international environment
- Experience in planning, implementing, evaluating operational activities and/or related projects

Experience in Search and Rescue activities and coast guard functions activities related to EFCA and EMSA mandate

Assets:

- Experience in leading teams in operational border control activities and / or other Coast Guard functions activities including Search and Rescue
- Appropriate professional knowledge related to the above-mentioned areas, including relevant EU and international law, in particular on the Schengen Border Code, UNCLOS, SAR/SOLAS, knowledge on issues regarding fundamental rights and access to international protection
- Experience in participation in maritime Frontex coordinated operational activities (Joint Operations/Rapid Border Interventions/Pilot Projects/Coast Guard functions etc.)
- Experience in operational centers related to border control activities and/ or other Coast Guard functions activities including MRCC
